The highest child poverty rate




3 out of every 10 children lives at or below the poverty level<sup>1</sup>

### Our families have borne the brunt of the past cuts

K-12

Per-pupil funding is 11% below 2008 levels when adjusted for inflation.<sup>5</sup> Higher Ed

Per-student funding is 32% below 2008 levels when adjusted for inflation.<sup>6</sup>

Child Care Assistance

We're serving 30% fewer families than in 2010<sup>7</sup> and eligibility still has not been restored to 2008 levels.

Meanwhile, we've given hundreds of millions away in tax cuts to big corporations and the wealthy

## Our budget is in crisis

# We need to raise revenue to balance the budget, and everyone should pay their fair share

<b>Delay corporate tax reductions:</b> Freeze the phase-in of the costly corporate income tax cuts enacted in 2013, and ensure that even the biggest corporations share the responsibility of making our budget whole again.	<b>SB 252</b> = \$23 million in FY17 & \$42 million in FY18
Modify personal income tax brackets:  Return some fairness to our tax system by lowering taxes for the middle class and ensuring that the highest earners share more responsibility for funding education, public safety, and infrastructure in our state.	HB 255 = \$50 million per year HB 126 = \$20 million per year HB 292 = \$26 million in FY17 & \$46 million in FY18
Expand tobacco product taxes: Increase tobacco taxes to raise revenues while also reducing smoking and public health care costs.	HB 300 = \$48 million per year SB 77 = \$60+ million per year
Repeal the capital gains tax deduction:  Costly and ineffective, this deduction has done nothing for economic development, and it means that earned income and wages are taxed at a <i>higher rate</i> than income from investments.	<b>HB 79, HB 220, HB 324</b> = \$35+ million per year
Increase permanent fund distributions:  Let voters decide whether to increase distributions from the \$14.4 billion permanent fund to buoy and expand our education system for children of all ages.	HJR 10, SJR 2 = \$100+ million per year

#### We can't cut programs that support the health and well-being of our families

Do not tax food	Taxing food jeopardizes public health in New Mexico and puts the burden of balancing the budget squarely on the backs of our kids and families.
Do not cut education	Our teachers are underpaid and our kids aren't meeting important education milestones.  We cannot cut education and expect to see any positive change.
Fully fund Medicaid	Cutting Medicaid by \$40 million means we'll cut health care to low-income kids and adults, the elderly, and the disabled by over \$200 million.1
